## **INVITATION FOR BIDS**

- 1. The Government of the Republic of Maldives has received financing from Abu Dhabi Fund for Development (ADFD) for the execution of R. Vandhoo Small Scale Waste to Energy (WTE) Project and intends to apply portion of the financing for eligible payments under the contract **the Supply and Delivery of Critical and Operational Spares for R. Vandhoo WTE**.
- 2. The Ministry of Finance (MoF), on behalf of the Ministry of Environment, Climate Change and Technology, wishes to bring the following changes to the Invitation for Bids reference number (IUL)13-K/13/2021/130 (20<sup>th</sup> April 2021) and invites bids from eligible and qualified bidders for **the Supply and Delivery of Critical and Operational Spares for R. Vandhoo WTE**.
- 3. **National Competitive Bidding (NCB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
- 4. The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
- 6. The Bidder shall furnish a Bid Security of MVR 27,000.00 (Twenty-Seven Thousand MVR or equivalent in USD) for the project. The Bid Security shall be valid for 148 days from the date of bid opening.
- 7. Any clarifications to the bid may be sent to below given e-mail addresses on or before 25<sup>th</sup> April 2021 at 13:30 hours.
- 8. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 9 of this Invitation for Bids, on or before **1000 hrs**Maldivian Time on 2<sup>nd</sup> June 2021, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
