> Below Change is brought to General Conditions of Contract for the Procurement of Works 49. Securities

49.1 The Performance Security shall be provided to the Employer no later than the date specified in the Letter of Acceptance and shall be issued in an amount **specified in the PCC**, by a bank or surety acceptable to the Employer from a reputable source from an eligible country. If the unconditional guarantee is issued by a bank, an insurance company or bonding company located outside the Employer's Country, it shall have a correspondent financial institution or bank located in the Republic of Maldives. The Performance Security shall be denominated in the types and proportions of the currencies in which the Contract Price is payable. The Performance Security shall be valid until a date 28 days from the date of issue of the Certificate of Completion in the case of a Bank Guarantee, and until one year from the date of issue of the Completion Certificate in the case of a Performance Bond.
