1. The Government of the Republic of Maldives has received financing from the World Bank towards Saafu Raajje - Maldives Clean Environment Project for Zone IV and V, and intends to apply portion of the financing for eligible payments under the contract for the above mentioned project.
2. The Ministry of Finance (MoF), on behalf of the Ministry of Environment, Climate Change and Technology, wishes to bring the following changes to the Invitation for Bids reference number (IUL)13-K/13/2021/108 (1<sup>st</sup> April 2021) and invites bids from local and international eligible and qualified bidders for the project **Procurement of Vehicles for Island Level Waste Collection Systems of Zone 2 (Batch 1)**
3. Bidding will be conducted through International competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *World Bank Procurement Regulations for Borrowers under Investment Project Financing, dated July 1, 2016, setting forth the World Bank's policy on conflict of interest* ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested bidders shall register with the Ministry of Finance for **the project**, between **8<sup>th</sup> April 2021 to 31<sup>st</sup> May 2021**, by: (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand and Five Hundred) or USD 100.00, through our online payment portal - Ban'deyri Pay (<https://bandeyripay.finance.gov.mv/>) and, (b) e-mailing the following information to the below given e-mail addresses:

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
6. The Bidder shall furnish a bid security of **USD 7,000.00** (**Seven thousand United States Dollars - or equivalent in Maldivian Rufiyaa**) for the project. The Bid security shall be valid for 148 days from the date of bid opening.
7. Any clarifications to the project may be sent to the address in clause 9 of this invitation for bids on or before **1330 Hours Maldivian Time on Thursday, 22<sup>nd</sup> April 2021.**
8. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 9 of this Invitation for Bids, on or before **1300 hrs Maldivian Time on 2<sup>nd</sup> June 2021,** at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
