INVITATION FOR BIDS

1. The Ministry of Finance and Treasury, on behalf of Ministry of Housing and Infrastructure (the Employer), invites bids from eligible and qualified bidders for the **Revetment Works at Th. Guraidhoo**.
2. The bidder shall be a listed member of the National Contractors Registry and shall satisfy the following grades in order to be eligible to participate in this tender.

HC01-1 & HC01-2
3. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred)** from **14th May 2015 to 27th May 2015** between **0830hrs and 1430hrs** on all working days. A complete set of bidding documents in electronic format shall be available for download from the Ministry of Finance and Treasury website www.finance.gov.mv
4. The Bidder shall submit a Tax Clearance Report obtained from Maldives Inland Revenue Authority. This document shall be dated no earlier than 5 (Five) days prior to the bid submission date.
5. The Bidder shall furnish a bid security of **MVR 300,000.00 (Maldivian Rufiyaa Three Hundred Thousand)** which shall be valid for 28 days beyond the validity of the Bid. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.
6. A pre-bid meeting will be held on **28th May 2015** at **1000 hrs** Maldivian time at the Tender Evaluation Section Meeting Room of the Ministry of Finance and Treasury.
7. Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 8 of this Invitation for Bids, on or before **1400 hrs** Maldivian Time on **10th June 2015**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
