2	Please note that the 6.5.20 of the TOR indicate that the consultant ensure and coordinate the training of staff regarding the proper use and maintenance of the equipment by the supplier, please explain whether the training should be provided by the consultant	Consultant is not expected to provide the training directly. Instead, the Consultant shall coordinate with the relevant contractors including the construction contractor (responsible for construction, furniture and fixed non-medical items) and the laboratory items supplier to ensure that the necessary training on the use and maintenance of the supplied equipment is provided to the NHL staff by the respective suppliers
