Question	Answer

The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Employer's Requirements. (b) For the above or other contracts executed during the period stipulated in 2.4.2 above, a minimum experience in the following key activities:	Cold storage work will be considered as related work. Civil works is not considered a related work but it is another requirement
(i) Supply and Installation of ice plant or related activities (ii) Civil works	
Question is that whether you consider the "cold storage work" as related work. Or civil works can be considered as related work too	
What exact documents are required to submit for manufactures authorization	A document issued by the manufacturer on their official letterhead indicating that the bidder is authorized/certified to install the equipment developed by the manufacturer
Couldn't find ITT 4.3, ITT 4.5 and ITT 29.1	Refer to ITT Clause 4.3, ITT Clause 4.5 and ITT clause 29.1 in the issued Bidding Document
Page 219, Couldn't find any ITB points	Page number 219 does not exist in the Bidding Document
What would be the space for the unit	A land area of 2000sqft (minimum) will be allocated for the site. Other requirements are provided in the technical specification
How big are the boats, the measurements for the space fish is stored or the volume of the water tanks	The sizes of the boats may range from 75ft to 100ft. The dimensions of the boats and the fish holds will vary from boat to boat.
Is there any requirements for water flow rate	No. This should be assessed and decided by the bidder. The technical specification will provide the requirements for cooling the fish
Under the chiller requirements, it's written it should be Titanium Shell and tubes, is it for both the evaporator and condenser or can the evaporator be titanium, and the condenser be of copper/nickel.	The chiller/evaporator unit should be Titanium. The Condenser can be made of copper/nickel.
