Revenue and Grants for May 2026 is 2,835.1 million, which is an increase of 0.8 percent compared to May 2025.

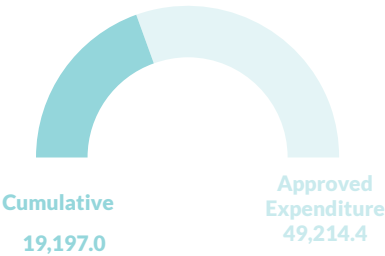
May 2026

Total Expenditure for May 2026 increased by 24.8 percent compared to the same period of 2025. Compared to May 2025, Capital Expenditure was 18.6 percent lower while Recurrent Expenditure increased by 33.4 percent.

IN MILLIONS MVR



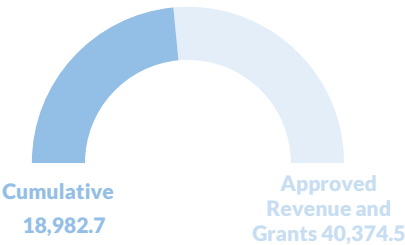
EXPENDITURE COMPOSITION - MAY
