Regarding the Procurement "Supply and Installation of 50 RSW systems in fishing vessels	The chiller/evaporator unit should be titanium. The Condenser can be made of copper/nickel.
(TES/2021/ G-016), we have some inquires. We would like to know the volume of the water tank or the measurements for the space fish is stored. Also,	
if there is a requirement for the water flow rate. Additionally, we would like to clarify as under the	
chiller requirements, it should be Titanium Shell and tubes, is it for both the evaporator and	
condenser or can the evaporator be titaniu, and the condenser be of copper/nickel.

What are the documents required as manufacture authorization?	
What is the capacity (tons / 24 hours) of the RSW Units to be supplied?	The RSW should have the capacity to cool 10 tons of fish from ambient temperature to 0-3 degree Celsius within 8 hours. For the purposes of this bid
Is it 10 tons / 24 hours?	the cooling capacity is given as time taken to cool X capacity of fish over an 8 hour period to 0-3 degree C

The piping necessary to fiber works of cutting, laying pipes and valves to fish hold tanks will be installed by the owners or this is part of the scope of the RSW supplier?	This is part of works for the supplier
What is the scope of works and supply and installation?	Supply, install and commission the RSW and the genset required for the functioning of the RSW
What is the is the Budget Allocated for 50 units?	Cannot be disclosed.
Or is installation meant as installing the RSW unit on the boat with Sea Water Pumps and connecting to the RSW unit to generator?	The scope is for the supply, installation and commission of the RSW systems on board a fishing vessel
