Revenue and Grants for April 2026 is 3,439.2 million, which is an increase of 8.2 percent compared to April 2025.

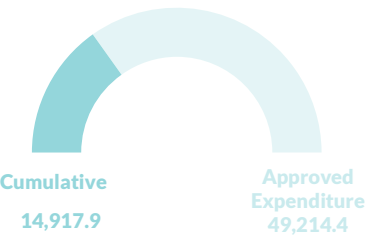
April 2026

Total Expenditure for April 2026 increased by 27.3 percent compared to the same period of 2025. Compared to April 2025, Capital Expenditure was 30.5 percent higher while Recurrent Expenditure increased by 26.8 percent.

IN MILLIONS MVR



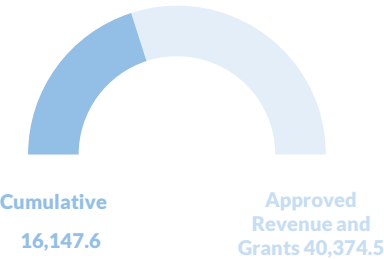
EXPENDITURE COMPOSITION - APRIL

DEFINITIONS
