## INVITATION FOR BIDS

1. The Ministry of Finance, on behalf of Ministry of Housing and Urban Development (the Employer), invites bids from local and international eligible and qualified bidders for the projects below.

2. Commencing on 30<sup>th</sup> March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades will be eligible to participate for this tender.
3. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
4. Interested bidders shall register with the Ministry of Finance, between **4<sup>th</sup> February 2020 to 4 March 2020 between 0830hrs and 1200hrs** on all working days, by: (a) payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to [aishath.nadheema@finance.gov.mv](mailto:aishath.nadheema@finance.gov.mv); and, (b) submitting in person or e-mailing the following information:
  - Name and Address of the Bidder
  - Name, e-mail ID and telephone numbers of the Contact Person(s)
  - Copy of the Payment/Transaction Receipt.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.

7. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.

Bids shall be valid for a period of **120 days** from the date of Bid of Opening and shall be delivered to the Ministry of Finance at the address specified in the Clause 9 of this Invitation for Bids, on or before **11:00hrs**, Maldivian time on **5<sup>th</sup> March 2020**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
