## **INVITATION FOR BIDS**

1. The Government of Republic of Maldives has allocated funds in the Annual Budget 2015 towards the cost of infrastructure development on Th. Thimarafushi, Maldives and intends to apply part of the proceeds under the contract, Design and Build Basis for Water Supply Network, Water Storage Tanks and Reverse Osmosis Plant and Allied Works based on Integrated Water Resources Management approach in Th. 2. The Government of Maldives, represented by Ministry of Finance and Treasury (MOFT) on behalf of the Ministry of Environment and Energy (MEE), now invites sealed bids from the eligible bidders for the works given above.
