The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) from May 3, 2015 to May 25, 2015 between 0830hrs and 1430hrs on all working days. 6. The Bidder shall furnish a **bid security** of amount **Maldivian Rufiyaa 130,000.00** (Hundred and Thirty Thousand Rufiyaa) which shall be valid for 28 days beyond the validity of the Bid. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.

Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to Ministry of Finance and Treasury at the address specified above in Clause 5 of this Invitation for Bids, on or before 1300 hrs Maldivian time on June 4, 2015 (Thursday), at which time they will be opened in the presence of the Bidders who wish to attend.
