INVITATION FOR BIDS

1. The Government of the Republic of Maldives has received financing from the Green Climate Fund (GCF) and intends to apply portion of the financing for eligible payments under the contract for the following projects.

The Ministry of Finance and Treasury on behalf of Ministry of Environment and Energy (the Employer), did not receive responsive bids to the Invitation for Bids Ref (IUL)13-K/13/2017/190 and therefore wish to annul the referred bidding process and re-invite bids from local and international eligible and qualified bidders for the following projects.

3. The Works to be performed under this Contract includes, but is not necessarily limited to Construction/Installation of Water Supply Network with Boreholes, Water Collection Tanks, RO Plant Unit, Storage Tanks and an Office/Administration Building and other related works
4. **International competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, single stage Dual envelope bidding procedure.

The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) **for each project** from **12th April 2018 to 30th April 2018** between **0830hrs and 1200hrs (During Ramazan: 1030hrs to 1230hrs) on all working days**. A complete set of bidding documents and any information that shall be delivered to the prospective bidders, shall be available for download from the Ministry of Finance and Treasury website www.finance.gov.mv
6. The Bid security shall be valid for 148 days from the date of bid opening.
7. Any clarifications to the project may be sent to the address in clause 9 of this invitation for bids on or before **1400 Hours Maldivian Time on Thursday, 19th April 2018**.
8. Bids shall be valid for a period of **120 days** from the date of Bid of Opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in the clause 9 of this

Invitation for Bids, on or before **1300 hrs, Maldivian Time on 02nd May 2018**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
