The Ministry of Finance (MoF) on behalf of the Ministry of Environment, now invites sealed Bids from eligible and qualified bidders for **Construction of Control Building & Waste Intake Building at Addu City Regional Waste Management Facility at S.Hithadhoo** and intends to bring changes to the Invitation for Bids Ref (IUL)13-K/13/2020/221 (18 November 2020) as follows.
2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
3. Only a listed member of the **National Contractors Registry** will be eligible to participate in this tender. International bidders shall seek all applicable **Foreign Investment Registration** and **Foreign Direct Investment Policy** requirements of Maldives prior to bid submission.

Interested bidders shall register with the Ministry of Finance for this project from **19<sup>th</sup> November 2020 to 23<sup>rd</sup> December 2020**. by: : (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand and Five Hundred) or USD 100.00, through our online payment portal - Ban'deyri Pay (<https://bandeyripay.finance.gov.mv/>) and, (b) e-mailing the following information to the below given e-mail addresses:

7.The Bidder shall furnish a bid security of **MVR 165,000.00 (Hundred and Sixty Five Thousand MVR or equivalent in USD)** for the project. The Bid security shall be valid for 148 days from the date of bid opening.

8.Bids shall be valid for a period of **120 days** from the date of Bid of Opening and shall be delivered to the Ministry of Finance at the address specified in the Clause 9 of this Invitation for Bids, on or before **11:00hrs, Maldivian time on 24<sup>th</sup> December 2020** at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
