  - a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00 (United States Dollar One Hundred), through our online payment portal Ban'deyri Pay (https://bandeyripay.finance.gov.mv/), or by

- electronic transfer to a designated bank account, information of which can be requested through email to above given email addresses, and;
- b) Once the payment has been confirmed, the applicant shall be registered upon submitting in person or by electronic mail, the following information to the address specified in paragraph 4 above:
