December 2024

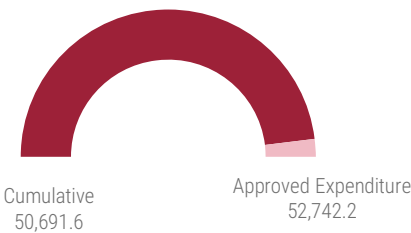
Revenue and Grants for December 2024 is 2,981.6 million, which is a decrease of 10.5 percent compared to December 2023.

Total Expenditure for December 2024 increased by 0.6 percent compared to the same period of 2023. Compared to December 2023, Capital Expenditure was 27.0 percent lower while Recurrent Expenditure increased by 26.2 percent.

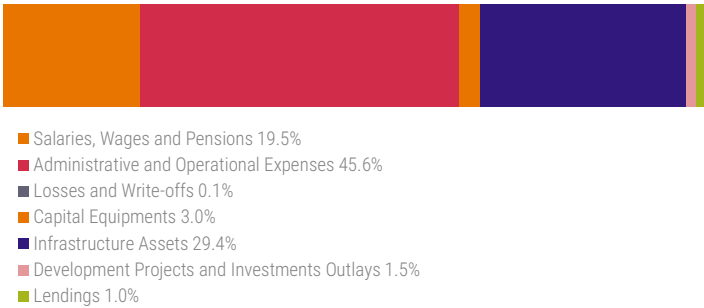
Fiscal Balance for the month of December 2024 is an overall deficit of MVR 3,038.3 million.

IN MILLIONS MVR

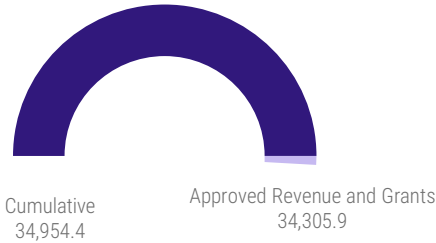


EXPENDITURE COMPOSITION - DECEMBER

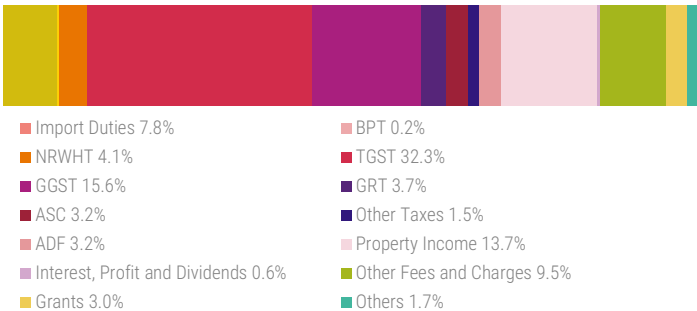


REVENUE AND GRANTS
